#### Make A Call/Send An E-Mail

In the September newsletter the telephone numbers of our senators and delegates were listed. I do hope you have called or will call your representatives and tell them of your support of a comprehensive reform of Maryland's tax structure. I strongly believe that the business community must pay its fair share of taxes.

We must insure that seniors across Maryland do not take an unfair tax hit or loss of services during the efforts to deal with Maryland's 1.5 billion dollar structural deficit.

The state's corporate tax has historically been 15 and 40 percent below the U.S. Average throughout the past 25 years.

A study by Ernst and Young for the Council on State Taxation (COST) found that for the FY 2006 Maryland ranked 48<sup>th</sup> among 50 states in the share of state and local taxes that were paid by businesses.

## FEDERAL LEGISLATION

On August 15th, the Labor Department's Bureau of Labor Statistics reported that the Consumer Price Index for Urban Wage Earners and Clerical Workers, the CPI-W, for July 2007 is 203.7, down 0.1 percent from the June index of 203.9. The CPI-W for July is 2.3 percent higher than the 2006 third quarter average base index of 199.1. For purposes of calculating the next COLA (cost-of-living adjustment) the index has increased 2.3 percent. Thus far, the index is 3.3 percent higher than the December 2006 base of 197.2

On September 13th, the Office of Personnel Management (OPM) released Federal Employee Health Benefits Program (FEHBP) rates for the 2008 plan year. NARFE President Margaret L. Baptiste is pleased with the overall average FEHBP premium increase of 2.1 percent for 2008.

Prior to the upcoming "Open Season," November 12, 2007 through December 10, 2007, OPM will mail CSRS and FERS annuitants detailed information about costs and benefits in FEHBP and about the Dental and Vision plans, now in their second year. Availability of dental and vision plans, along with their premiums and benefits will vary, are not dependent upon enrollment in the FEHBP, and unlike the health insurance plans, enrollees will pay the full cost of any elected option.

More detailed information on plans, benefits, and costs will be available at our October Health Screening meeting.

## STATE LEGISLATION

### Legislative Strategy 07-08

The hazy, lazy days of summer did not keep your State Legislative Committee (SLC) from meeting and working out a plan of action for the upcoming legislative session.

The bad news is that the legislators will be focused on reducing the deficit. The good news is that the legislators will be looking for ways to reduce the deficit. Our focus for the session will be to work with like minded organizations to convince the Governor and the legislature that the best solution is to revamp the state's tax code so that we can get wording necessary to equalize the senior tax deduction which was denied us when the tax code was last overhauled, and

to lobby to have the tax credits for Long Term Care premiums included as a part of the revision.

To insure that the deficit is not paid for by cutting benefits for all seniors or introducing taxes which will further increase the tax burden on all citizens, already one of the heaviest in the U.S., we will be lobbying to raise corporate income tax rates, currently one of the lowest in the nation; closing loopholes which allow businesses to avoid paying millions of dollars in taxes; and tearing down special interest fences which, for example, allow the beer, wine, and spirits industries to pay the same tax rate as they paid in the 1980's.

3. Flu Shots 1:00 PM until 3:00 PM, Flu Shots are for MEMBERS & SPOUSES ONLY. Reserve your flu shot by calling Barbara Wheatley at 301 352 6241 or leave a message on the voice mail leaving your NAME and PHONE NUMBER. Also e-mail [wheatley0@aol.com](mailto:wheatley0@aol.com) THIS REGISTRATION IS REQUIRED FOR YOUR FLU SHOT. NO WALK INS. A return call will be made to all who leave messages. As each person calls for a reservation, you will be given a number which indicates your turn to get your shot. In other words, if your number is 5, you will be the 5th person to get your flu shot. There will be a sheet at the sign-in table with your name and number on it. If you have Medicare Part B, bring your card (no charge). If you have Aetna and are 65+, bring both your Medicare card and your Aetna card. If you are under 65 bring your Aetna card (no charge). Maxim Health Systems will file your claim. If you do not have either of these programs, you must pay cash or write a check payable to Maxim Health Systems the \$25 cost for the shot. ### . . . And a Warm Welcome Back to 'Reinstated Members'

While I'm offering warm welcomes, I must mention those members whose dues had lapsed, national had dropped -- but who then paid up and were reinstated. Every month, we average 2-5 reinstatements; these mainly are "annual members" who, for whatever reason, didn't respond to dues reminders sent by national NARFE and often by the chapter as well.

### Retirees Win With Dues Withholding

Why am I mentioning this group? Because for retirees there's an easy way to avoid that drop/pay up/reinstatement cycle: it's dues withholding (DW)-- the simple, painless way to pay NARFE dues. When you sign up for DW, your national and chapter dues are withheld from your annuity checks, approximately \$2.50 each month. This means no dues notices, no checks to be mailed -- and the best of all -- you get a discount of approximately \$4.50 each year! Think about it! This savings nearly covers your annual \$5.00 chapter dues!

For a dues withholding form, call me (see pg. 4) or pick one up at a membership meeting. Note: Even if you just paid your dues, fill out a DW form now and NARFE will hold it until your anniversary date.
