### FEDERAL LEGISLATION

A Senate Finance subcommittee took a hard look last month at two provisions of the Social Security Act that adversely affect hundreds of thousands of retired government employees across the nation.

NARFE has for years sought the repeal of the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP) because they reduce social security benefits earned by federal retirees and former state and local government employees.

At a news conference prior to the hearing Nov. 6, NARFE President Margaret L. Baptiste commended Sen. John Kerry (D-MA) for spotlighting the effects of the two provisions.

"Senator Kerry deserves our thanks for using his position as the Chairman of the Social Security, Pensions, and Family Policy Subcommittee to review policies undermining the earning retirement benefits of more than a million public servants," Baptiste said.

Sen. Susan Collins, the opening witness at the hearing, testified in support of S. 206, legislation she

is co-sponsoring with Sen. Dianne Feinstein (D-CA) that would repeal both the GPO and the WEP.

The GPO prevents federal retirees from collecting both their annuity and a social security benefit based on the work of a spouse. The WEP reduces social security benefits based on their own work of many federal retirees.

An estimated 971,000 public sector retirees are affected by the WEP—and 20 percent of them had paid into social security for at least 21 years.

More than 400,000 social security beneficiaries are affected by the GPO, about 72 percent of them women and many of those widows. An estimated 85 percent lost their entire social security benefit because of the GPO.

The GPO “is most harsh for those who can least afford the loss, and that is lower income women,” Senator Collins testified.

She said the offset reduces benefits by more than \$3600 a year for more than 200,000 retirees—“an amount that can make the difference between a comfortable retirement and poverty.”

The subcommittee also heard from retirees who are personally experiencing reductions in their benefits.

“It is a situation that is, frankly, intolerable,” Kerry said.

## STATE LEGISLATION

The Maryland Federation of NARFE now has a Political Action Committee (PAC). The necessary paperwork was sent to the state and was returned with approval to the Federation in early November. The only other existing PAC at the Federation level is in Virginia. More details to follow in the coming months.

The United Seniors of Maryland (USM) will have its annual Maryland State Legislative Rally at St. John’s College, Annapolis on January 22, 2008 (January 29 is the alternative date if the meeting is postponed because of weather). All Maryland seniors are invited to attend. There will be an opportunity to meet with some of our local legislators. More information will be provided at the January general meeting. Carpooling will be available for anyone interested in attending.
