#### CONVENTION RESOLUTIONS

It is time to think of resolutions or proposed bylaws/standing rule amendments at the National Convention in Louisville, Kentucky in September 2008. Proposals for National resolutions should be meaningful and cover problems that need correcting. Local issues need not be aired before the entire NARFE membership. The guiding principle in any submission is whether the submission is necessary and will ultimately improve NARFE. Any submission by chapters must reach the Federation Secretary by February 20, 2008. #### FEDERAL LEGISLATION

The government giveth — and the government taketh away.

Federal retirees got their COLA increase for 2008, but those over 65 with Medicare Part B know for a fact that health care costs are going up faster than the cost-of-living overall.

The COLA for retirees under the Civil Service Retirement System came to 2.3 percent. The COLA was 2 percent for retirees under the Federal Employees Retirement System (FERS)—a lesser amount because social security is integrated with FERS. The 2008 federal annuity COLAs are the lowest in four years.

Social security COLAs match the 2.3 percent paid under CSRS.

The bad news for 2008 is that Part B Medicare monthly premiums jump from \$93.50 to \$96.40 for most participants—an increase of more than 3 percent.

An estimated 5 percent of Medicare beneficiaries will pay even more because they have higher incomes. In adding a prescription drug option to Medicare, Congress also tucked in a provision tying Part B premiums to income.

Individuals with annual incomes ranging from \$82,000 to \$102,000 will pay an additional \$25.80 a month, hiking their premiums to \$122.20. That surcharge is stepped up for those with higher incomes.

Retirees will have a month to adjust to those changes before new rates kick in under the Federal Employees Health Benefits Program.

Monthly premiums for the standard Blue Cross/Blue Shield plan will be going up \$10.51 to \$134.66 for Individuals. For families, the premium will be jacked up \$23.49 to \$314.47.

Blue Cross/Blue Shield has been the most popular by far among the FEHBP fee-for-service plans but the new rates may have sent some participants scurrying to plans with more modest increases.

GEHA touted no increases at all in premiums for its standard and high deductible plans and actually reduced monthly charges for its “high self” and “high family” plans.

USM 2008 Legislative Priorities include resolving the deficit in services for seniors by addressing qual-

ity long-term care, fraud and abuse, affordable health care and related critical needs. Scheduled to speak are Governor O’Malley and Gloria Lawlah, Secretary, Maryland Department of Aging. The event starts with registration from 8:15-9:00 a.m. and continues until 2:30 p.m. The \$15.00 registration fee includes continental breakfast and lunch.
