You can contribute almost any amount, in minimum increments of \$25. ## FEDERAL LEGISLATION

Federal retirees were spared from the domestic spending reductions proposed in the fiscal 2009 budget President Bush sent to Congress in February.

For retirees, “this budget is mostly good news because it has so little bad news,” NARFE said in its preliminary assessment of the spending proposal.

There was at least one dark cloud on the fiscal horizon, however.

The proposal includes a plan to expand Health Savings Accounts (HSAs) in the federal health insurance program, an option NARFE opposes because of the likelihood that younger, healthier, higher-income employees would opt for HSAs. This could trigger higher premiums for those remaining in comprehensive health plans.

Relatively few federal workers or retirees have enrolled in HSAs up to now, but the budget proposal would allow Blue Cross/Blue Shield, the most popular federal health plan, to offer HSAs.

NARFE fears that the BC/BS “brand name” could jump start HSAs to the detriment of older employees and retirees who need comprehensive coverage.

## STATE LEGISLATION

The Maryland Federation’s State Legislative Committee (SLC) finalized and distributed the Federation’s 2008 Maryland Legislative Program pamphlet. Their main objectives are to equalize tax exemptions for pensions of public service employees, military retirees, and Maryland’s seniors; to create an annual credit for long-term care (LTC) insurance premiums; and to reduce the tax burden on senior homeowners.

The SLC is tracking notable tax bills affecting seniors and others during this legislative session. NARFE members have and will testify on bills we support. Members continue to meet with legislators to gain their support for our positions. We continue to seek the support of other like-minded organizations.

The SLC cannot be successful without your help. We need members to be present at all hearings. You don’t have to testify, but be a member who sits in the session and supports members who are testifying. This will ensure our legislators know there is a contingency of concerned citizens. We need members to call their legislators and ask them to support our legislative bills. We also need members to sup-

### New-member Survey Results

To find out how active federal workers and retirees learn about NARFE, why they join, and what they expect to derive from the organization, for about 18 months we mailed a survey to all new chapter members. It was sent with a welcome letter, the chapter newsletter and a yearlong list of programs. We also asked what they thought of our meetings, programs and newsletter.

Although the response was low, the overwhelming majority of those who answered the survey were satisfied with our meeting schedule and found the newsletter informative. They liked the variety of our programs; their program suggestions included nearly all the topics we have addressed over the years as well as a couple of new ones. Not surprisingly, nearly all the respondents agreed on what they expect to gain from joining NARFE; summed up, they are “Vigilant monitoring of legislation” and “Fighting to prevent any erosion of benefits.” In addition, most respondents expected that NARFE would provide “good fellowship,” “collaboration, communication and sharing with those who have similar goals and objectives,” and a place for listening, learning and being informed by speakers and members.

The survey appears to reinforce our chapter’s ongoing attempts to recruit and retain members via our proactive membership program as well as our publicity/outreach program. Although about one third of the respondents learned of NARFE at workplace retirement seminars, nearly a third joined after discovering NARFE on the web, through the media, or from members in other organizations. Two respondents became members by “assuming” their deceased spouse’s membership — a benefit that both national NARFE and the Chapter heartily encourage.

But, most importantly, the remaining third joined because of friends who are NARFE members.

As membership chair, I believe that my oft-repeated messages that “every member must be a recruiter” and that “one-on-one recruitment efforts work” are clearly reflected in the survey results. Therefore I en-
