#### FEDERAL LEGISLATION

Judy Park, NARFE's long-time legislative director, retired at the end of May after a remarkable 40-year career with the organization. All of us should join in saying "thank you" for all she has done for NARFE and its members.

NARFE's primary mission is "to protect and improve the retirement benefits of federal retirees, employees and their families." As director of NARFE's legislative staff since its creation in 1976, Judy has been in the forefront of the never-ending effort to carry out that mission.

Some provisions of the federal retirement program we take for granted now wouldn't be there if it weren't for the work of Judy and other NARFE leaders.

Examples include increasing the government's share of health insurance premiums, participation by retirees in open seasons for the Federal Employees Health Benefits Program, restoring full annuities to retirees upon the death of a survivor, granting survivor benefits to second spouses and extending those benefits to spouses in post-retirement marriages.

Lobbying for legislation to improve retirement benefits is important but NARFE also has to play defense at times. It wasn't all that long ago that the reduction or deferral of COLAs was a perennial threat on Capitol Hill as Congress looked for ways to pare federal spending. That threat could come back to haunt us again in the current budget crunch.

Judy Park certainly is well aware that NARFE must maintain a strong presence on Capitol Hill.

"I think, for the foreseeable future, the big issues will be protection of benefits federal employees have that

are being discounted and diminished in the private sector," she said. "The biggest challenge will be to protect what they have, particularly with inflation protection and the health benefits program that transfers from employment to retirement without any reductions."

To Judy, let us say, "Thank you." And to Dan Adcock, her successor as NARFE legislative director, "Keep it going and good luck."

## CURRENT FEDERAL EMPLOYEES

*From The Chapter 1127 Newsletter*

HR5781, the Federal Employees Paid Parental Leave Act of 2008, if passed, would provide four weeks of paid parental leave for all federal employees, and would permit employees to use their accrued sick leave for an additional eight weeks of paid parental leave. No date has been set for floor consideration. HR5573 was introduced to allow FERS employees' accumulated sick leave to be partially "cashed out" at retirement, and HR5550 was introduced to raise the maximum age to qualify for coverage as a "child" under the health benefits program for federal employees. Over 20 cosponsors introduced HR 5718 to improve family and medical leave for federal employees and to require GAO to study the feasibility of offering disability insurance to federal workers. Contact your congressional representative to urge passage of these bills
