#### PRESIDENT'S MESSAGE

During the recent National Convention, delegates approved NARFE's Legislative Program that reaffirms commitment to preserving the earned economic and health security of federal annuitants and workers; supports legislation to allow civilian and military retirees to pay for their choice of health insurance premiums with pre-tax dollars; and legislation to repeal or reform the unfair and arbitrary Social Security Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP). Newly added parts of the program include: support of legislation allowing FERS employees credit for unused sick leave toward retirement, and legislation extending FEHBP coverage of dependents of federal employees and retirees until age 25.

Thank you to **Marjorie Laios** and **Barbara Wheatley** who helped **Dorothy Campbell** and **Ed Bice** staff our information tables at the recent Bowie Senior Information Fair and Odenton Day.

Congratulations to Chapter members **Harriet Bury**, **Dale Grant**, **Tom Page** and **Ed Bice** who participated in the Maryland Senior Olympics in September. All earned at least two medals.

#### FEDERAL LEGISLATION

##### Historic Financial Rescue Bill

Lawmakers burned the midnight oil to complete work on a controversial and historic financial rescue package to address serious problems in the credit markets and prevent the Nation from sinking into a deep recession.

On October 3, 2008 the House passed the \$700 billion Emergency Economic Stabilization Act, H.R. 1424, clearing this legislation for the President's signature. The vote was 263-171. The President signed the bill into law the very same day.

The House voted to reverse its earlier defeat of the rescue bill, due in part by calls from fearful constituents experiencing difficulty securing loans or lines of credit. Many lawmakers were also persuaded by revisions to the bill to include fresh financial disaster assistance and tax breaks for families and businesses, adding \$107 billion over the next 10 years.

The main provisions of the bill will allow the Department of the Treasury to do the following:

- ❖ Treasury Secretary Henry Paulson to buy up to \$700 billion in bad mortgage-related securities and other bad assets.
- ❖ Treasury Department to modify mortgage terms to help homeowners avoid foreclosure.
- ❖ Government to receive equity in companies it helps so that taxpayers get a share of future profits.
- ❖ Restrict executive pay for companies aided by the program.
- ❖ Create an independent oversight board to oversee the Treasury Department program.

This bill also contained some controversial add-on provisions unrelated to Wall Street. They include \$8.3 billion a year for research tax credit for companies; \$109 million this year for NASCAR racetrack builders; \$62 billion this year to spare 24 million households from an increase in the alternative minimum tax; \$478 million in 10 years for movie or TV producers who shot films in U.S.; about \$200,000 per year to repeal a 39 cent excise tax on wooden arrows for children; \$17 billion of incentives to promote alternative energy; \$8 billion for Americans affected by hurricanes and floods; and \$192 million for rum producers in Puerto Rico and Virgin Islands.

One can only guess the impact the Rescue Program will have on the Federal deficit, which is soaring to record heights. One thing is for sure, the Treasury will have to borrow the money: The bill increases the legal debt limit by \$700 billion to \$11.3 trillion.

Upon completion of the bill, the House joined the Senate in adjournment for the November elections, subject to the call of the chair.

The next cost-of-living adjustment (COLA) for millions of retired and disabled Americans will be 5.8 percent, the largest since March, 1982. The FERS annuity adjustment will be 4.8 percent.

The September 2008 Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) is 214.935, a decrease of 0.1 percent from the August index of 215.247.

## STATE LEGISLATION

The State Legislative Committee (SLC) held a one-hour training session at the October Federation meeting. The legislative handbook developed by the committee was distributed to chapter presidents and chapter points of contact.

The attendees wrote cards—addressed to Governor O’Malley—detailing our support of legislation that will equalize the additional personal tax exemption for all Maryland residents 65 and older.

SLC members continue to seek sponsorship for our priority legislative goals in the 2009 General Assembly session.

The Maryland Political Action Committee (MD-PAC) is still seeking your support. Political involvement and financial assistance are necessary to achieve our goals. The Maryland PAC was recently used to send representatives from the Gaithersburg, Rockville and Bowie-

Crofton Chapters to fundraisers for two state delegates. MD-PAC receives requests from politicians for support. If it is determined by the committee that he/she is a friend of NARFE and would support our 2009 agenda, then support is considered. We need to participate in as many of these types of events as possible.

### ‘Distinguished Members’ Replaces ‘Honorary Members’

Although your three Chapter 1747 delegates to the NARFE National Convention (Ed and Dorothy Bice and I) voted AGAINST it, a two-thirds majority of the delegates voted to drop the category of “Honorary Member” and replace it with a new category: “Distinguished Member.”

As was the case with Honorary Members, each Distinguished Member will be recognized with a special pin and ID card when they reach their 85th birthday if they have been a NARFE member for 20 years. HOWEVER (and this is why we voted against the national by-law change), Distinguished Members will still have to pay national dues; previously national dues for Honorary Members was waived. The waiving of chapter dues was always discretionary; our chapter’s policy was to waive it for Honorary Members—and we will continue to waive chapter dues for both Honorary and Distinguished Members.

The new change “grandfathers” current Honorary Members; they will not have to pay national dues. However, if they wish to “upgrade” (NARFE’s language!) their status to Distinguished Member, they may do so by continuing to pay national dues!

The delegates who voted to make this by-law change evidently did so based on financial considerations, including the large number of current Honorary Members and the aging of NARFE’s membership. However, your delegates believe that NARFE should continue to hold in high esteem those members who fill the age/membership requirements—and changing the name of the dues category AND charging them dues is belittling and wrong-headed.
