FEDERAL LEGISLATION

2010 Budget

Before passing their fiscal 2010 budget resolution on April 2, 2009, the House of Representatives defeated a substitute amendment offered by Rep. Paul Ryan (R-WI) which would have cut entitlements, such as Social Security, Medicare, and Medicaid by \$1.3 trillion over ten years and would have included a reduction of

\$10.263 billion in federal civil service retirement and health benefits. The Ryan substitute amendment was defeated 137 to 293.

The Senate adopted a similar, but not identical, budget resolution (S. Con. Res. 13) setting the stage for a House-Senate Conference Committee after the Easter/Passover recess (April 5 – 18).

FERS: SICK LEAVE AND TSP

On April 1, 2009, the House approved H.R. 1804, legislation which would allow Federal Employees Retirement System (FERS) employees to credit their unused sick leave toward their retirement and would make certain improvements to the federal Thrift Savings Plan (TSP).

The bill would automatically enroll newly hired federal employees in the TSP and make them eligible to receive an immediate matching contribution from their employing agency.

Moreover, the measure would widen TSP's offered plans to include a "Roth" option like

many private employers do in 401 (k) plans. Under a "Roth" option, contributions are after taxes have been paid. Roth plan principal and earnings can be withdrawn tax free. House passage of this legislation is a victory for federal workers, but it still must be approved by the Senate where the NARFE Legislative Department is already promoting it.

STATE LEGISLATION

The 2009 session of the Maryland General Assembly has ended. There is no good news to report as our top three priorities received no favorable action.

I encourage members to attend our General Membership Meeting on May 21st when state legislators from Districts 23 and 33 have been invited to review the recently concluded session. Each legislator will be given time for remarks, followed by a question and answer session -- and I hope you will be there to ask why our priorities were not addressed again.

One Step Forward, Two Steps Backwards

As you can see, there are 12 names of new members below on our "welcome list." Eleven are members recruited by national NARFE, and one is a "transfer" from another chapter. In addition,

three previously dropped chapter members requested reinstatement.

While those numbers sound great, they're still very troubling. First, the fact that national NARFE recruited all 12 new members shows that Chapter 1747 didn't sign up anyone in the past month. But, more importantly, the monthly membership report that provided the good news above also indicated that national NARFE dropped nine members for non-payment of dues and one member voluntarily canceled his membership. And, even worse, the national office had to send "second notice reminders" to 26 chapter members (18 retirees and 8 active members) stating they would be dropped shortly if they didn't respond to that mailing.

Since this pattern regularly occurs, membership in 1747, as well as in the majority of chapters, seems to be "taking one step forward and two steps backwards." Obviously, we can't keep NARFE solvent or strong that way.

What can chapter members do? We can, and must, all actively recruit: spouses, family members, friends, neighbors, former coworkers — both retirees and those still working. Pick up membership forms at meetings or contact me (see back page). Sign up new members. Let's go forward and make our organization bigger and better and more powerful.
