## FEDERAL LEGISLATION

### Health-Care Bill

The House Democrats and one Republican achieved an unprecedented milestone by passing a health-care reform bill. In a rare Saturday session held November 7, 2009, the House narrowly passed a trillion dollar health-care package that seeks to reform private health-care insurance practices and guarantee coverage to almost every American. The vote on H.R. 3962 was 220–215. Thirty-nine Democrats, mostly from the party's conservative ranks, did not vote for passage of the bill. However, one Republican did vote for the bill, Rep. Anh "Joseph" Cao of Louisiana, who represents the Democratic-leaning district of New Orleans. Rep. Cao had been the target of a last minute White House lobbying campaign. Rep. Cao disappointed GOP House leaders who had predicted their members would unanimously oppose the bill.

Not since the passage of Medicare and Medicaid in 1965 has a body of Congress approved expansion of health-care coverage on such a scale. Attention now shifts to the Senate, where debate on health-care reform could run until the end of the year. Majority Leader Harry M. Reid (D-Nev.) hoped to bring a measure to the floor before Thanksgiving.

Under this legislation federal employees and annuitants will be able to keep the insurance in the system they have now and nothing in the bill specifically impacts Federal Employees Health Benefits Program (FEHBP). However, any comprehensive plan that changes insurance law, provider financing, taxation policy and health infrastructure, will have some ramifications on how FEHBP operates in the larger health system.

### National Defense Authorization Act

On October 28, 2009, President Obama signed the Conference Report on the fiscal year 2010 National Defense Authorization Act (H.R. 2647, now P.L. 111-84). During the past several years, NARFE has played a leading role, in coalition with other federal and postal union and management organizations, in overcoming several obstacles to pass the needed civil service improvements included in the final Defense Authorization bill.

The new law does the following: Allows federal agencies to re-employ federal retirees on a limited, part-time basis without offset of annuity; permits Federal Employees Retirement System (FERS) workers to initially credit half, and in 2014 all, of their

unused sick leave toward retirement; phases out the non-foreign cost-of-living adjustment system for federal employees in Hawaii, Alaska and U.S. territories, replacing it over several years with locality pay, which can be counted for retirement purposes; and ends the Department of Defense's pay-for-performance personnel system, the National Security Personnel System (NSPS), restoring employees to the federal General Schedule pay system.

## STATE LEGISLATION

Joe Young and Ed Bice attended a campaign fundraiser for Del. Jim Hubbard (District 21) on October 27 in Bowie. All members of the District 23 team were there as well as other delegates from Districts 14, 21, and 46. Chapter Presidents and members of the State Legislative Committee have gone to fundraisers during the summer and fall throughout the state. We lobbied the legislators for their support on two of our priority issues: equalizing tax exemptions for Maryland's seniors and providing an annual tax credit for long-term care insurance premiums.

MDPAC supports our participation in these efforts. It is the federation's political action committee which is in its second year. By going to selected fundraisers, we raise the presence of NARFE and our state legislative program. Also, we have another opportunity to lobby our own representatives as well as others at the same event. We will continue to support those officeholders who express their support of NARFE and our agenda at the state level.
