FEDERAL LEGISLATION

Deficit Reduction Agreement

The Budget Control Act of 2011 (Senate Bill 365) was passed by the House of Representatives on August 1, 2011 by a vote of 269-161. It was sent to the Senate on August 2, 2011 and passed by a vote of 74-26. The President signed it into law the same day it passed in the Senate. The following are some of the highlights of the Budget Control Act of 2011:

- Extends the debt limit to 2013.
- Makes approximately a one trillion dollar down payment on deficit reduction.
- Expedites the process for a balanced deficit reduction in a longer term process for at least an additional \$1.2 trillion in savings.
- Creates a proven enforcement mechanism that will compel across-the-board spending cuts (50% defense/50% non-defense) if Congress does not act.

Deficit Reduction Agreement Details

Stage one of the plan includes approximately \$917 billion in deficit reduction through the establishment of ten-year caps

PROGRAMS

The Chapter is planning a series of programs for September 2011-June 2012 that promise to be informative, interesting and entertaining. On September 15 Reginald Ward from METRO Access/Rail/Bus will speak on their local transportation programs for seniors, including discount fares. The October 20 meeting focuses on Federal deficit reduction plans and their impact on employees or retirees. Chapter Federal Legislative Chair Joe Young will conduct the program, along with Kristen Soper, assistant to Senator Barbara Mikulski

In a change from previous years, the November meeting will be devoted to Open Season and our Federal health plans, and the meeting will NOT be on a Saturday, but on Thursday, November 17. On December 15 we will host our holiday luncheon at the Blue Dolphin.

Looking ahead, January 2012 will be our regular income tax information meeting. February we expect to have a speaker from Maryland RELAY, a free public service that enables anyone to place calls to a person who is deaf, hard of hearing, speech disabled or DeafBlind and who uses specialized telephone equipment. Other programs are in the planning stages and we will keep you informed.

Retirees Are Valuable

The State Legislative Committee (SLC) met during the summer. Besides the usual MDPAC business, the main emphasis was on how to utilize a North Carolina study of 2008 (that was updated in 2011) for our purposes. One of our purposes is the development of more friendly state tax policies for seniors and retirees.

The study was first brought to our attention in 2010 by member Dick Strombotne. Since then our members have shared the study and its results with legislators, NARFE members, and allied organizations. In conjunction with military groups, we used this study in support of HB 744, sponsored by Delegate Love (D-Dist. 32), during the 2011 Legislative session.

We are focused on how to get a study similar to the North Carolina effort initiated and completed in Maryland. The North Carolina study documents that retirees are a terrific economic and fiscal stimulus to the state. For instance, for every \$1.00 in tax breaks for retirees, the state receives \$2.50 in return.

The SLC fully expects to develop legislative objectives for the 2012 session. When this is completed, the SLC legislative pamphlet will be printed and distributed.

The state’s fiscal situation is less than ideal as a shortfall of approximately one billion dollars is projected for July 1, 2012. The question remains whether any revenue enhancing actions will be taken during the special session in November.

which will save \$756 billion and an additional savings from interest savings. In the first two years, there will be separate caps for security and non-security spending. These caps include security spending for defense, state and foreign operations, homeland security, and military construction and veterans affairs.

Total discretionary spending in Fiscal Year 2012 and 2013 will be limited to \$1.043 trillion and \$1.047 trillion, respectively. This represents about \$7 billion and \$3 billion below current spending levels, respectively.

The plan gives the President the authority to immediately raise the debt ceiling by \$400 billion, which the Treasury Department estimates will last through September 2011. Another \$500 billion debt limit increase would be subject to resolutions of disapproval votes in both the House and Senate. The disapproval measure would be subject to a presidential veto.

Stage two of the plan requires the formation of a joint, bipartisan committee, made up of 12 members (6 from each Chamber, equally divided between Democrats and Republicans, and appointed by the Majority and Minority Leaders in each Chamber) tasked with developing future legislation to achieve at least \$1.2 trillion in future deficit reduction by Thanksgiving 2011. The committee's legislation can include entitlements and revenues and will be guaranteed an up-or-down Senate and House vote, without amendments, by December 23, 2011.

If the committee fails to produce legislation that achieves \$1.2 trillion in deficit reduction or Congress fails to enact the commit-

tee's recommendation, sequestration is triggered. Sequestration forces across-the-board spending cuts.

Sequestration will use a balanced approach to spending cuts:

- Fifty percent of the cuts will come from Defense and fifty percent from non-defense spending. The spending cuts would apply to fiscal years 2013-2021 and apply to both discretionary and mandatory spending programs with important exemptions. If sequestration is triggered, the defense spending cuts are estimated to be over \$50 billion each year.
- Social Security, Medicaid, veteran benefits, other essential benefits are exempt from cuts if across-the-board cuts are triggered.
- Medicare savings are capped at 2% and are limited to provider only — no benefits will be cut.
- The last time an enforcement mechanism like this trigger was used — with 50% domestic and 50% defense cuts — the threat of defense cuts helped drive the 1990 bipartisan agreement under President George H. W. Bush that included both revenue and spending reductions.

Future Votes on Balanced Budget Constitutional Amendment

As part of the compromise, both the House and Senate will vote on a balanced budget constitutional amendment before the end of the year. The plan does not make the debt limit increase contingent on passage of the amendment. Nor does it prevent a vote on an alternative version of the balanced budget amendment.

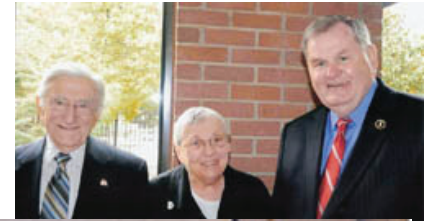

You Can Decline the FERS Retirement Supplement

A FERS employee under age 62 who retires on an immediate annuity (an annuity that is payable within 30 days of an employee's separation for retirement) is eligible for a FERS Special Retirement Supplement. It represents what you would receive for your FERS civilian service from the Social Security Administration (SSA) and is calculated as if you were eligible to receive SSA benefits on the day you retire. At age 62 the annuity supplement ends and the retiree **MUST APPLY FOR SOCIAL SECURITY** for an equivalent payment. Like Social Security the retirement supplement is subject to outside earnings limitation and is reduced by \$1.00 for every \$2.00 of earnings over the minimum level (for 2011, the annual limit is \$14,160). The limit does not apply after one reaches the Social Security Full Retirement Age (FRA) which varies from 65 to 67 depending on one's month and year of birth. Many Social Security eligible workers do not apply for Social Security at age 62 because they know they will be earning substantially more than the earnings limitation and they would have to return all or a portion of their Social Security payment for that year.

While the FERS supplement is an integral part of the FERS retirement system, OPM regulations do not specify a procedure for declining the supplement if one knows he/she will be working and earning more than the outside earning limitation upon retirement and would prefer to forgo the payment. This omission of information regarding declining the supplement was brought out in a question posed by a FERS employee under age 62 who was going to a full-time job upon retirement; the employee asked a Chapter 1747 Service Officer whether he could decline the supplement. The Service Officer and the employee contacted OPM which answered: "YES. Please put your request to cancel the supplemental annuity in writing and send it to our office. We will have the annuity waived."

Although I have experience in HR and worked as a retirement counselor in an agency retirement operations center, all Chapter Service Officers listed on page 4 have received NARFE training and possess authoritative source information for answering your retirement questions. We are here to serve you!
