Paul and his family moved to Washington, DC in 1960 when he joined the Washington Post as a reporter. He and his family moved to Bowie, MD in 1962 where they lived for more than 50 years. After leaving the Post, Paul worked for the Democratic National Committee and then began his federal career working for several agencies including the Food and Drug Administration, the Social Security Administration, and the Environmental Protection Agency. After retiring from the Federal government, Paul joined Chapter 1747 of NARFE where he held a number of positions including President, Treasurer, Chapter Editor, head of the State Legislation committee and Service Officer. We were blessed to have this talented man be a member of our chapter and may he rest in peace.

FEDERAL PAY RAISE: DECISION DELAYED

Congress approved five of 12 spending bills which provided approximately 70 percent of discretionary funding for FY19. However, with the passage of a continuing resolution, lawmakers have delayed the deadline for the remaining appropriations, including a federal pay decision, until December 7, 2018. The president's proposed pay freeze

will be implemented unless Congress passes the remaining appropriations before January. While the Senate included a 1.9 percent average pay increase, the House has not yet passed an increase. The fate of this pay raise will depend on the 26 conferees coming to a bicameral agreement and reconciling the differences between the two chambers different versions of H.R. 6157. NARFE MEMBERS SHOULD CONTINUE TO CONTACT THEIR LEGISLATORS. NARFE makes it easy to contact your legislator. Contact NARFE's Legislative Action Center, a one-stop site to send a letter to Congress. The Legislative Action Center can assist you in identifying your Congressperson and includes a letter already drafted where you simply fill in your personal information if you desire. This proposed pay raise is not the same as the COLA that the retirees will receive. Consult page 9 of your December NARFE Magazine for details.

WEP REFORM

The Windfall Elimination Provision (WEP) reduces the benefits of federal retirees covered by the Civil Service Retirement System (CSRS) who earned Social Security benefits through other employment. NARFE has supported a change in WEP for several years. A new WEP Reform Bill has been introduced - H.R.6933 - the Equal Treatment of Public Servants Act of 2018 - which would provide for an additional monthly payment for those whose Social Security benefits are reduced by WEP. STATE LEGISLATION

MOVING FORWARD

The State Legislative Committee (SLC) over the summer reviewed the survey results based on the three questions which denoted our legislative priorities for 2019. Based on November's election results committee members have been assigning legislative districts to arrange meeting with election winners who have supported our issues on the survey. The purpose of the meeting with legislators is to receive their agreement to sponsor/cosponsor legislation which will be introduced by Governor Hogan and/or by members of the General Assembly which supports our issues.

ISSUES for 2019

- 1.) Permit Maryland taxpayers to itemize deductions on their MD tax returns whether or not they use standard deduction on their Federal tax returns.
- 2.) Extend the tax exemptions of \$15,000 on pensions of military retirees over the age of 55 and the \$5,000 for those below 55 to the pensions of Federal, State and local public service retirees.
- 3.) Increase the supplemental tax exemption of \$1,000 for elderly taxpayers and their elderly spouses to match the \$3,200 exemption that can be claimed for elderly dependents.
